Please, remember to enclose the appropriate tax payment stub (1st or full payment) along with your personal check, cashiers check or money order (no cash will be accepted). If you require a tax payment receipt or are requesting a dog license (tax payments & dog license payments must be paid separately) please include a self-addressed, stamped envelope. All mail postmarked on or before December 31st and/or January 31st will be accepted without penalty. There will be a \$25.00 charge for all returned checks.

Pay at Town Office Secure Drop Box: Located outside our office at N5794 Old Keshena Road is a Secure Drop Box for tax payments & dog licenses. All drop box payments will receive a tax receipt. Place your tax payment, the appropriate stub in the provided envelope or one of your own, seal and place in the box (no cash). If you need a dog license, place vaccination record and payment in the same envelope (tax payment and dog license payments must be paid separately.) I will mail your tax receipt / dog license back to you.

Pay in person: Starting Monday, December 12th you can pay in person and obtain a dog license at N5794 Old Keshena Road. Tax payments and dog license fees must be separate. We accept personal, cashiers checks & money orders. No cash. Hours are 9 a.m. – 3 p.m. Monday – Thursday. There will be NO OFFICE TAX COLLECTION ON FRIDAYS, WEEKENDS OR HOLIDAYS. THERE WILL BE NO OFFICE COLLECTION ON DECEMBER 16TH, 23RD, 30TH JANUARY 6TH, 13TH, 20TH OR 27TH. DUE TO SITUATIONS BEYOND OUR CONTROL (I.E. ILLNESS / INCLEMENT WEATHER) THERE MAY BE OFFICE CLOSURES AND ALTERED COLLECTION HOURS. I apologize for any inconvenience.
