A RESOLUTION AMENDING UNIFORM FEE SCHEDULE

WHEREAS, the Town of Wescott has adopted Ordinance 2021-01- adopting a Code of Ordinances

WHEREAS, The Code of Ordinances refers to a Fine-Fee- Forfeiture Schedule by Resolution, as directed in individual ordinances,

WHEREAS, Ordinance 2026-01 repeals and replaces Ordinance 2020-06, Mandatory Garbage and Recycling, to comply with the Department of Natural Resources requirements, which includes fine penalties


WHEREAS, The current fine and forfeiture schedule conflict with Ordinance 2026-01 associated with the Mandatory Garbage and Recycling Ordinance.

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Wescott, Shawano County, by this resolution, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and Wescott that the attached Uniform Fee Schedule is hereby adopted and in force, effective Ferbruary 23rd 2026 and that any and all fee schedules are revoked and superseded by the attached uniform schedule.
