Paying your Taxes

- ➔ **AMERICAN BANK** at **115 Front Street** Beaver Dam You **must** take your tax bills with you. Open Monday – Friday from 9:00 to 5:00 pm.
- ➔ **WESTFORD TOWN HALL** at W11101 Co Rd G. 20 January 2024 and 27 January 2024 from 8:30 to Noon
- ➔ **MAIL** payment to Town of Westford Treasurer N8881 Hickory Point Rd, Beaver Dam WI 53916

Half and full payments of 2023 taxes are due and payable on or before January 31, 2024.

Any overpayments of taxes will be refunded at the February 5th and March 4th 2024 Town meetings.

Building Permits

Town of Westford requires all residents to obtain a building permit for new construction work or remodeling that exceeds \$5,000. Building permits can be acquired from the Town Chair for \$100. If construction begins before a building permit is obtained, fees double.

All new home construction requires inspections. Additional fees are levied by the inspector based on the value of the project.
The Town of Westford Building Inspector is General Engineering (800)955-7876.

*It is illegal to plant trees, shrubs or erect permanent structures within the town right of way (33' from the center of the road).
When in doubt ask the town chairman.*

Rubbish Drop-Off

Bulk drop-off will be a dumpster set at the town hall the first Saturday of June and the first Saturday of October.

**PLEASE NOTE: NO garbage, including yard waste, can be dumped or burned in the road ditches.
Fines may be levied against anyone caught dumping or burning in the road ditches.**

Lottery Credit

You are only eligible for lottery credit if your residence in Westford is your primary residence for more than six months.

Special Charges

The garbage collection rate of \$16.77 a month from April to November plus interest of the loan acquired to secure garbage service will be a special charge on your tax bill. You can find a schedule for 2024 garbage pickup at townofwestfordwi.gov
All properties within the Beaver Dam Lake District (shoreline property) will incur a special charge of \$46.86.

Dog Licenses

Dog licenses are due NOW for 2024.

All dogs (indoor and/or outdoor) having reached the age of 5 months must have a current rabies vaccination and be licensed.
Any dogs spayed or neutered since last year must furnish proof of such before the license can be issued. Any dog owners failing to obtain the license for their dog(s) before April 1, 2024 will be required to pay an ADDITIONAL late fee of \$10.00 PER DOG LICENSE in ADDITION to the required license fee. The fees are as follows:
