# **DOG LICENSE INFORMATION**

#### **APPLICATION FORM ON BACK** →>>>

All dogs kept within the Town of Vienna, Dane County are <u>required</u> by Wisconsin State Statutes to be licensed <u>each</u> calendar year. The fees for all dogs licensed for the 2024 calendar year January 1, 2024 thru December 31, 2024 are as follows:

### Male/Female \$23.50 Neutered Male/Spayed Female \$18.50

We will again use one dog license application form, which will allow residents the opportunity of licensing more than one dog per application. This form is located on the back of this sheet and is also available on the Town's website: www.vienna-wis.com

The Town of Vienna requests that all dog licensing fees be **paid by separate check**. Please do not add your dog license fee to your tax payment. Your license can be obtained or renewed through the mail (address provided below) and your dog/s license and tag/s will be mailed to you within a few weeks of receipt.

If you wish to apply for a new license <u>or</u> renew your dog/s license and your dog's rabies vaccination shot is expired, you are required by the State to provide the Town with a valid rabies vaccination certificate prior to the issuing of the license. This rabies vaccination certificate must include date of shot, expiration date, manufacturer, serial number, tag number of the rabies shot and sex of dog. Your veterinarian may fax this information to the Town at 846-3829, emailed to treasurer@viennawi.gov or it must be enclosed with your payment. When applying for a new dog license please enclose the valid rabies vaccination certificate described above and the appropriate fee.

Without this information we are unable to complete the paperwork and the license will <i>not</i> be issued.
