Department of Administration Approves Towns Petition To Incorporate

On September 17, 2009, the Wisconsin Department of Administration approved the Town of Bristol's petition to incorporate the Northwest portion of the Town as a Village and sent its results to the Circuit Court. The Circuit Court has set a referendum date for Tuesday, November 3, 2009. There will be two polling places: the Town Hall, 19801 83rd Street; and the Senior Center, 19200 93rd Street (Hwy C). The polls will be open between 7:00 a.m. and 8:00 p.m. Only those residents within the proposed Village will be allowed to vote.

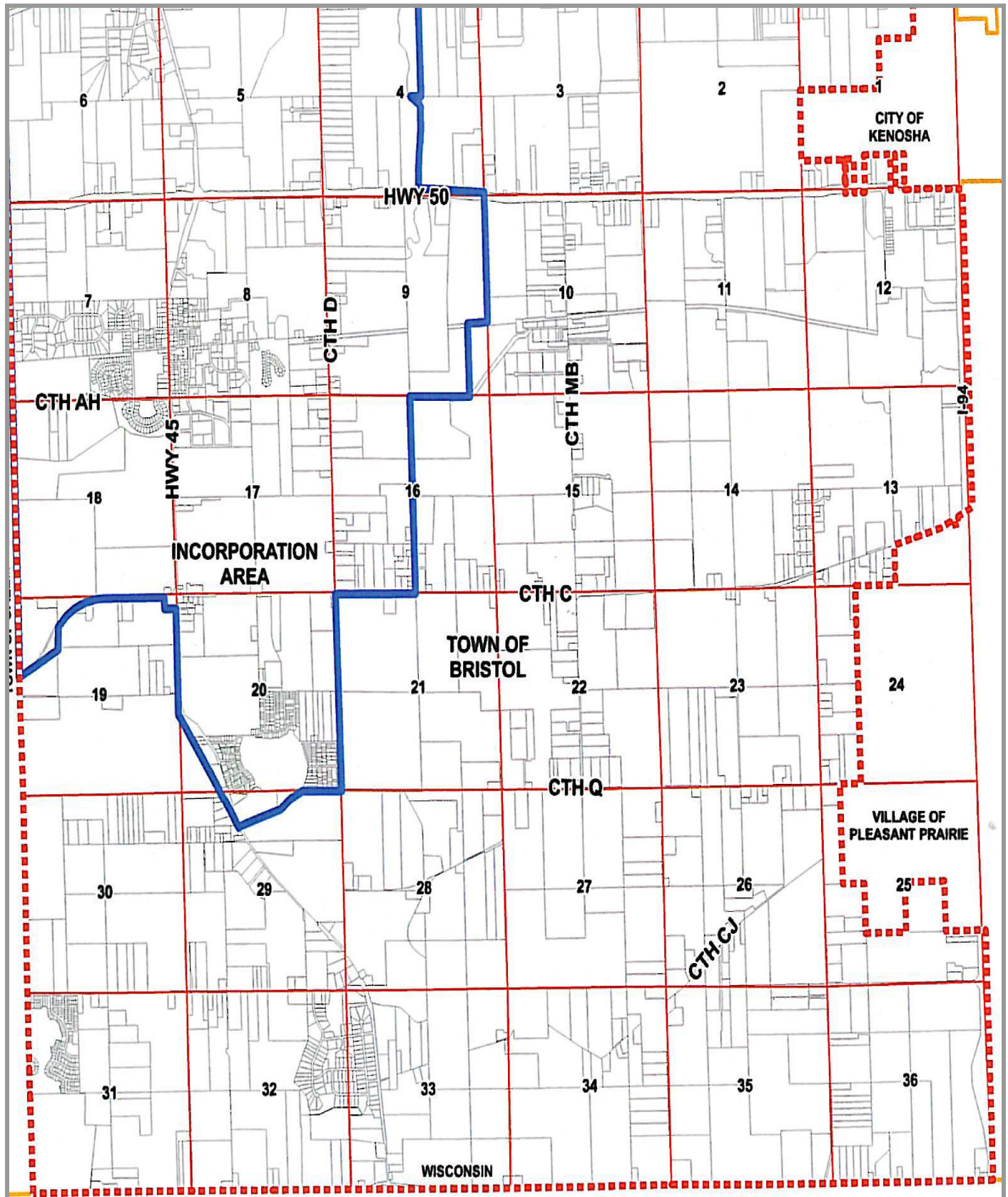
There will be another public meeting at the Town Hall, on Thursday, October 22nd at 7:00 p.m. to answer any questions residents may have prior to the vote. The Town will also send out a postcard reminding the proposed Village residents of the

voting date a week before the vote.

If the vote is favorable, there will be a 60-day period to hold elections for six new Village Board members and a Village President. At the same election, any open positions on the Town Board would be filled.

Town Chairman, Richard Gossling, said, "We are delighted that the citizens of the proposed new Village of Bristol will have a opportunity to vote on their future. The new Village will have an agreement with the existing Town to maximize efficiency and minimize overlap of services."

Please remember to get a burn permit if you have not done so already. Remember to call the "Burn" line at 857-4063 to find out if burning is permitted for each day. You must also remember to follow the guidelines that are on the permit as conditions can change during the day. "Be kind to your neighbors when burning."

We recommend you have a Carbon Monoxide (CO) detector in your residence in the sleeping area. CO is a colorless, odorless gas that can kill you if there is a problem with gas appliances or the chimney flue is blocked.

Remember to check your smoke detectors on a monthly basis and practice Exit Drills with a predetermined meeting place outside your residence.

We need to be able to find your residence or business, so please make sure you have your address numbers (3 inches high) on your house if within 100 feet of the street or on a post or mailbox at the road. Ordinances and Postal regulations require this to be done as well as finding you for an emergency.

CPR CLASSES

Public Works Department

With winter coming soon, snow issues become more prevalent. Public Works would like to remind residents of the following:

- When snow blowing or shoveling your driveway, try to move the snow to the right of your driveway as you are looking at the street. If you put it on the left, side the snow plow may carry it back into the front of your driveway. This will not eliminate the snow but should reduce the amount that ends up at the end of your driveway. It also violates town ordinance to plow or blow snow into the road. Any snow put into the road may cause the resident or business to be ticketed.
- Snow and ice control of sidewalks and driveways is required of the property owner.
- Piling of snow in front of fire hydrants or sprinkler connections is illegal.

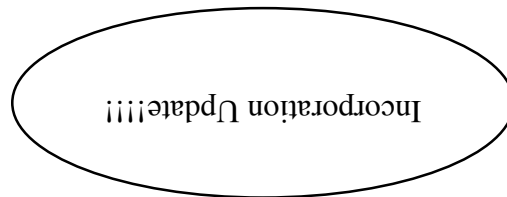
Please help out by keeping fire hydrants clear of snow if they are near your residence or business.
