ORDINANCE No. 2016-6

AN OMNIBUS ORDINANCE REAFFIRMING VARIOUS ZONING & LAND DIVISION APPROVALS AND COMPREHENSIVE PLAN AMENDMENTS

The Village Board of the Village of Bristol, Kenosha County, Wisconsin, do ordain as follows:

SECTION 1. ADOPTION OF PROVISIONS.

Section 13-1-11 of the Village of Bristol Code of Ordinances is created to read as follows:

Sec. 13-1-11 Blanket Rezonings, Land Division Approvals and Comprehensive Plan Amendments.

- (a) **Purpose.** The Village Board of the Village of Bristol has previously approved a number of rezonings, land divisions and Bristol Comprehensive Plan amendments as set forth on the attached Exhibit A, which is incorporated herein by reference. To ensure that all technical requirements pertaining to these prior approvals were properly satisfied, the Village Board desires to reaffirm these prior actions by adoption of this Ordinance.
- (b) **Reaffirmation of Earlier Approvals.** The blanket rezonings, land division approvals and Comprehensive Plan amendments are hereby reapproved and affirmed, following public hearing and recommendation from the Plan Commission, with parcels and specific reapprovals (rezoning, land division approval and/or Comprehensive Plan amendment) as set forth on the attached Exhibit A.

SECTION 2. SEVERABILITY.

If any provision of this Ordinance is invalid or unconstitutional or if the application of this Ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provisions or applications.
