# Arbor Day Celebration will be May 9th

The Arbor Day celebration will be held at the same time and place as the Grand Opening of the Dog Park. We will be putting wood chips around a few of the trees that were planted. There will be 50 Black Cherry Seedlings available for the volunteers to take home or plant at the Dog Park. This is Bristol 's 4<sup>th</sup> annual Arbor Day / Tree City USA celebration. This certification allows the Village to apply for and receive various arbor grants through the Wisconsin Department of Natural Resources and American Transmission Company. The Village received a grant for \$19,628 that we were reimbursed for work done in 2013 and 2014 in regards to tree inventory and treating Ash trees for Emerald Ash Borer. The Village was then able to plant 54 trees in or near the right of way on the streets that surround Bristol School.

The Village ordinance 12-2-1 (2) states no person shall fire or discharge any rifle, pistol or shotgun loaded with a single slug or single ball projectile in the Village of Bristol within seven hundred (700) yards of any building or residence without the express permission of the property owners, or on legally posted land forbidding hunting or trespassing.
