### Referendum

At the April 3 Spring Election, voters will be asked to vote on the question: "Elimination of state treasurer. Shall sections 1 and 3 of article VI and sections 7 and 8 of article X of the constitution be amended, and section 17 of article XIV of the constitution be created, to eliminate the office of state treasurer from the constitution and to replace the state treasurer with the lieutenant governor as a member of the Board of Commissioners of Public Lands?"

Before you can vote you need to be registered to vote. You can register on the same day as the election. The polls are open from 7:00 am—8:00 pm


Refreshments will be served.

Specifics regarding the move will be posted on the BWHS Facebook page (<a href="https://www.facebook.com/Bristolwisconsinhistoricalsociety">https://www.facebook.com/Bristolwisconsinhistoricalsociety</a>) to keep everyone informed. The route is Hwy C west to Hwy 45, Hwy 45 north to 84th St., 84th St. east to 198<sup>th</sup> Ave, 198<sup>th</sup> Ave north to the park entrance. The move is tentatively scheduled for the week of Monday April 16<sup>th</sup>.

### History of the original Bristol Town Hall

In 1869 the people of Bristol started building their first town hall. On October 15, 1869 the land where the building is located was given to the township for one peppercorn and one dollar. In legal parlance, a peppercorn is a metaphor for a very small payment, a nominal consideration, used to satisfy the requirements for the creation of a legal contract. The Building was completed one year later in 1870. The building was built in the geographical center of Bristol as it was in 1869. The land is now part of the Kenosha County Bristol Woods Park. The building is being used as a storage shed and the only access for the public is a 15 minute walk using a path from the Pringle Center.


On the north side of the gas station, you'll find the Subway restaurant, which includes a drive-thru window. Subway's hours of operation are 7am-10pm.

# Fire Department—New Ladder Truck

# **Expected Delivery Date is April, 2018!**



Construction of the new Truck 5231 at Pierce Manufacturing in Appleton, WI has progressed quickly over the past nine weeks with the Department's Apparatus Committee now scheduled to complete its second inspection of the apparatus Thursday, March 22nd. Reliant Fire Apparatus, the regional Pierce dealer, has provided weekly photo reports depicting the apparatus in the various stages of the extensive fabrication process. The apparatus is now largely assembled with the engine, fire pump, water/foam tanks, cab and body having been fitted to the complete chassis, and the aerial ladder device is expected to be installed in early to mid April. The Department anticipates final inspection of the new apparatus in late April with delivery immediately following. Training of qualified apparatus driver/operators and the installation of equipment into the new apparatus will take place for approximately six weeks after the new Truck 5231 is delivered, and a formal ceremony placing the apparatus into service will be scheduled. Next week the cab and chassis may be staged for content installation while the forward PUC pump module may finish the paint process and the body may begin the paint process in metal finishing.

# VILLAGE ORDINANCE Junk Vehicles Sec. 11-6-3 ( P)

## Unlicensed or Unregistered Vehicle Area.

Any place in the Village on private property where for a period prescribed in Section 10-5-8 an "unlicensed" or "unregistered" vehicle is parked, stored, or otherwise kept outside a building without the written permission of the Village Board or designee that is not timely removed or discontinued within the Village designated compliance time of receipt of written notice to remove from the Village Board, or designee, unless applicable exemptions apply.

### Frequently-Asked Questions


### Why can't I bring latex paint?

Latex paint is not considered to be a hazardous material. As such, it can be disposed of through paint swaps, donation or by putting it in the trash.

The recommended method for trash disposal is to put kitty litter in a box, spread the paint over the litter and allow to dry, then dispose of it with your garbage. There are also paint hardeners that can be purchased at a hardware store.

#### Where is the Public Works Garage?

The driveway for the Kenosha County Public Works Garage is located on Hwy. 50 (75th St.), on the north side of the road (east of the driveway to the main entrance for the Kenosha County Center.) There will be signs on Hwy. 50 directing you.

### What is the Household Hazardous and E-waste Recycling Event?

A once-a-year collection of household hazardous chemical wastes.

E-waste (electronics) and refrigerant wastes (household cooling appliances) are also accepted!

#### Who is eligible to participate?

Any Kenosha County resident!

#### What electronics are accepted?

- Computers, including laptops
- Fax machines
- Keyboards, mice, etc.
- Stereos
- TVs and VCRs
- Scanners
- iPods, DVD, CD & MP3 players
- **Printers**
- Phones (including cell phones)
- Power tools
- Copiers
- Toner cartridges
- **Electronic toys**
- Hair dryers
- Water coolers
- Refrigerators
- Vacuums Toasters
- Stoves
- Freezers
- Microwaves
- Washers/dryers
- Air conditioners
- Dehumidifiers
- Water heaters

- There is no fee for the collection of any hazardous waste or E-waste material.

These materials will NOT be accepted.

#### How should I handle and transport the hazardous waste?

Keep products in original containers.

Seal containers tightly to avoid leaking. Place it in a leak-proof container.

Do not mix products together.

Pack containers in sturdy boxes in the trunk or in the rear of your vehicle.

Store products away from kids, pets and fire.

Outdoor fires require a burn permit, which is *valid January - December*.

First time permits cost \$25 and renewals are \$15. Please call the Fire Dept. burn line at 857-4063 for the current burn status just prior to burning.

Permits can be purchased at the Village Hall or at the Fire Department nights and weekends, and are valid January through December.
