### **Bristol Progress Days**

is an old fashioned community event that will be celebrating its 50<sup>th</sup> Anniversary in 2019. This event is held with very limited taxpayer involvement. The Bristol Progress Days Committee is a self running, non for profit organization that pays for various marching bands in the Bristol Progress Days Parade and funds the fire-works display that we all enjoy on Sunday evening.

The cost of the Parade is \$3,900 and the cost of the Fire Works is \$7,200. All totaled up, the Committee has to raise \$25,500 each year to cover costs of the entire event. The Progress Days Committee has been able to pay for this event through donations and fundraising all year long. The Village of Bristol donates the Public Works employees' time to assist in the set up, take down, and cleaning up of the event. The Village Board also donates \$1,500 to Bristol Progress Days. A large part of the fund raising is having the Progress Days vendors donate 15% of the sales from the food booths located at Hansen Park during the weekend event.

We would like to thank all who attend Bristol Progress Days at Hansen Park. Your patronage to the vendors helps to fund the majority of this annual celebration. The Bristol Progress Days committee is always looking for volunteers to help with the many hours of planning, organizing, and delivering a small town experience for all to enjoy. # GARBAGE & RECYCLING

*This is a reminder for single family residences* - that the third Thursday is large pick up day for garbage. The Village set this up to keep up a clean community. If you have stuff lying around the house or in the house that you would like to get rid of, put it on the curb for the 3<sup>rd</sup> Thursday of the month. Garbage should not be set out until 6 pm the night before pickup.

Please remove the garbage and recycling containers back away from the roadway by 6 pm Thursday. Use this similar schedule when pickup is delayed by holidays. Put the garbage cans out the night before the holiday scheduled pick up, and take the containers away from the roadway the evening of the pickup day.

## ASH TREES

The emerald ash borer has a 100% kill rate unless you have been treating the ash trees. We would like to remind you that the ash trees that are dead need to be removed by the property owner. We understand this may be a large task for some properties with the amount of trees. Please remove the more dangerous trees (overhanging property lines and buildings) first. It is less costly to remove the trees before they are completely dead because the tree removal service can climb them to remove. When the tree is dead it is too dangerous for the climber and a bucket truck will be needed. All brush and branches can be taken to the recycling center (19500 block of 81<sup>st</sup> street) Monday – Friday 7am-3pm. And the first and third Saturday 9 am till noon.

# **FLOODING**

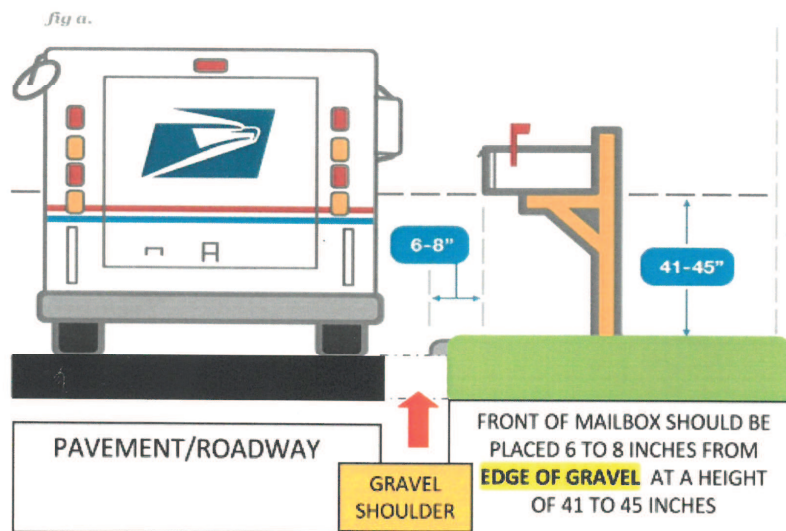
The Village of Bristol Public Works does inspect and televise sanitary sewer mains. They can tell if a sump pump is hooked up to the sanitary sewer with the television camera. It is illegal to have your sump pump hooked up to the sanitary sewer under Village of Bristol ordinance 9-1-6(a).

The penalty is a minimum of \$500 and \$100 per day until it is removed. The reason is just a couple sump pumps hooked up to the sanitary sewer can over burden the sewer line causing backups in neighbors houses.

# GUIDELINES FOR MAILBOX POSITIONING BY ROADWAY

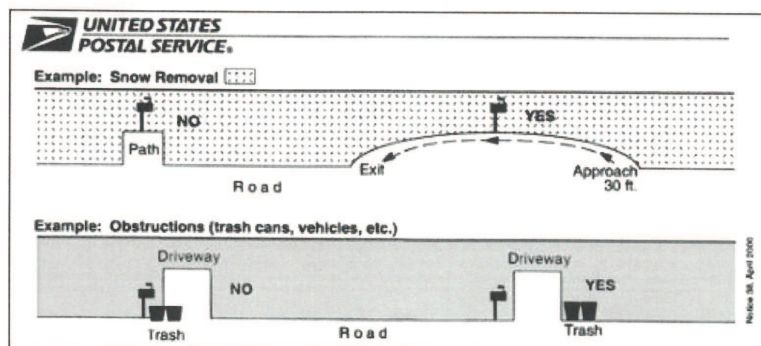


The paving project is now complete.

*First time permits—\$25*

*Renewal permits—\$15*

Permits can be purchased at the Village Hall or at the Fire Department nights and weekends.
