*****POLLING PLACE LOCATION CHANGE*****

Due to the COVID-19 virus, changes have been made to our polling locations for the upcoming election on April 7th.

There will be ONE polling location for ALL Bristol residents, which will be at the Village Hall location: 19801 83rd Street.

The Village of Bristol Municipal Office will be closed for day to day business until further notice. The <u>only exception</u> will be for obtaining an absentee ballot form, absentee voting, or registering to vote. Hours for voting are M-F 8am-4pm thru April 2nd, and 8am-5pm on April 3rd.

All payments can be made online at villageofbristol.org, or if paying by check can be placed in our drop box located by our front doors.

Please visit our website for any updates on office hours and for contact information. All business is being done by phone, email, or fax.

We thank you for understanding the changes that have had to be made in lieu of the COVID-19 situation.

The Village of Bristol Administration and all other Village of Bristol Departments are actively coordinating with and participating in the Kenosha County Emergency Operations Center (EOC) that has been partially opened to support a prepared and coordinated response to all emergencies during the evolving COVID-19 situation.



VOTER REGISTRATION

Information provided by the Wisconsin Elections Commission

WHEN CAN I REGISTER TO VOTE?

By mail. Up to 20 days before the election. Registration forms should be mailed to your municipal clerk. You can start your voter registration form online at http://myvote.wi.gov. Your form must be printed, signed, and mailed or delivered, to your municipal clerk. You must always provide a Proof of Residence document when registering. If you are registering by mail, you can use any of the forms of Proof of Residence except a residential lease.

Online. Up to 20 days before the election. Voters who have a valid State of Wisconsin Driver License or State of Wisconsin ID card issued by the Wisconsin Division of Motor Vehicles (DMV) can register to vote online on the MyVote Wisconsin website: http://myvote.wi.gov. To register online, the voter must enter a name, date of birth, Driver License or ID number, and an address that matches what is on file with the Wisconsin DMV. If all of the fields match, the voter will be able to register to vote completely online without needing to print, sign or mail the form and without needing to send a proof of residence document. Voters who are not able to match their information with the information in the DMV database will be given the option to register by mail (see instructions above).

In the municipal clerk's office. You may register in-person in your municipal clerk's office up until the Friday before the election at 5:00 p.m. or close of business, whichever is later. You must always provide a Proof of Residence document when registering to vote.

At the polling place on Election Day. You may register at the polls on Election Day. You must always provide a Proof of Residence document when registering to vote.

WHAT DO I NEED TO BRING TO REGISTER TO VOTE?

If you have been issued a State of Wisconsin Driver License or ID card that is current and valid, you must provide the number and expiration date. If your WI driver license is cancelled or expired; or your WI DOT-issued ID is expired, provide the number and the last four digits of your Social Security number. If you have not been issued a WI driver license or WI DOT-issued ID, you must provide the last four digits of your Social Security number. If you have none of these documents, you will be able to indicate that fact.

You must provide a Proof of Residence document when registering to vote in Wisconsin. A Proof of Residence document is a document that proves where you live in Wisconsin. Please see the Proof of Residence handout for a list of acceptable documents.

IS THERE ANYTHING ELSE I NEED TO KNOW ABOUT REGISTRATION?

<u>Photo ID is never required when registering to vote</u>. However, a Proof of Residence document is always needed when registering to vote in Wisconsin.

Voters must reside at their address for at least 10 days by Election Day in order to register to vote. Voters who have moved within Wisconsin less than 10 days before the election must vote from their previous address, either by absentee ballot or at the polling place. Voters who have moved to Wisconsin from another state less than 10 days before an election are only eligible to vote in Presidential elections.

Wisconsin law no longer allows a "corroborating witness" to provide Proof of Residence. See the "Proof of Residence" documents for a list of Proof of Residence documents.

You cannot register the Saturday, Sunday, or Monday before an election, but you can register at the polling place on Election Day.

Frequently-Asked Questions


Why can't I bring latex paint?

What else do I need to know?

Responding to the 2020 Census is:

> Easy

Every household in the United States will receive a notice to complete the census in early 2020. You can complete the form online, by phone, or by mail.

> Safe

Your personal information is confidential, is protected by law, and can never be used to identify you. It can never be shared with law enforcement agencies or your property manager.

> Important

Businesses and leaders in your community will use the data collected in the census to make decisions about where to build new buildings, revitalize old ones, open stores, create jobs, and more.



Is the Census Bureau hiring?

Yes! Earn extra income while helping ensure that everyone in your community is counted. The U.S. Census Bureau has a variety of temporary jobs that need to be filled, including census takers, recruiting assistants, office staff, and supervisory staff. You must be at least 18 years old, have a valid Social Security number, and be a United States citizen to be eligible.

The census counts every generation.

Every 10 years, the United States counts everyone who lives in the country, from newborn babies to the oldest among us. It is important for everyone to complete the 2020 Census so that communities like yours can be accurately funded and represented.

Responding is important.

The 2020 Census will influence community funding and congressional representation for the next decade. Information collected in the census will inform the allocation of more than \$675 billion in federal funds for states and communities each year. That includes money for things like:

- > First responders
- > Medicare Part B
- Supportive Housing for the Elderly Program

- Libraries and community centers
- Supplemental Nutrition Assistance Program (SNAP)
- Senior Community Service Employment Program

Responding is easy.

Beginning in mid-March 2020, you can respond to the census online, by phone, or by mail. Choose the option that is most comfortable for you. Large-print guides to the questionnaire are available upon request. From May – July 2020, census takers will visit households that have not yet responded. A census taker can assist if you need help completing your form.

Responding is safe.

Your personal information is kept confidential by law. Your responses can only be used to produce statistics. They cannot be shared with law enforcement agencies or used against you by any government agency or court in any way.

Property managers, make it count.

Property managers like you are critical to the success of the 2020 Census. As a trusted voice among your tenants, you can raise awareness of the 2020 Census and increase response. Your efforts will help provide accurate data to improve communities across the nation.

> What is the timeline?

In early 2020, every household in the United States, including those living in rental housing, will receive a notice to complete the census online, by phone, or by mail.

How can I help?

Share information with tenants so they know when and what to expect. Also, provide census takers access to your properties to help tenants complete their form if they haven't already done so.

> How do I benefit?

Accurate data can be a valuable asset in determining where to build new rental properties and how to market your business.

> Is the 2020 Census secure?

Yes. Official census takers will carry government-issued identification with them at all times. The personally identifiable information they collect is kept confidential by law.

Everyone counts in group housing.

No matter where you live, it is important that you are counted in the 2020 Census. Information collected in the census will help determine funding for vital community resources, congressional representation, and more.

You should be counted where you live and sleep most of the time. If you live in a group facility, like a dorm, military barracks, or shelter, U.S. Census Bureau employees will work with a representative from your building to make sure you are counted. You may be asked to complete an individual census form.

Your building may include you in its count.

Those living in most group facilities, including college dorms, nursing homes, psychiatric and other medical facilities, correctional facilities, group homes, and some shelters, will be counted in one of the following ways:

- > A representative from your building will electronically submit your information to the Census Bureau. It will be encrypted to make sure it remains confidential.
- > A Census Bureau employee will interview a representative from your building in person.
- > A Census Bureau employee will drop off paper census forms for residents to complete, and pick them up later.
- > At some medical and correctional facilities, a representative from your building will work as a census taker to collect information from the facility's residents.

A place where you receive services may include you in its count.

Census Bureau employees will work with transitional shelters, meal centers, and other places where people receive services to make sure everyone is counted. If you are staying in one of these places, or are experiencing homelessness and receive services there, you may be counted through an in-person interview with a census taker. A representative from the service's facility may submit a roster to the Census Bureau to make sure nobody is missed.

The military may include you in its count.

If you live in a military barracks or dormitory, a representative will count you as part of the facility. If you are assigned to a military vessel with a home port outside of the United States, you will be counted using data from the U.S. Department of Defense. Re: Change in Bulk Collection Services from Johns Disposal

Dear Residents,

As you may already know, the Village has recently accepted a proposal from Johns Disposal Service to change the way bulk items will be collected. Previously, your bulk items were collected on the third Thursday of every month.

Effective January 1, 2020, Bristol residents are required to call Johns at 262-473-4700 and schedule each bulk items collection. Under this new 'bulk-on-call' program, you will now be able to select your collection week each month.

Each residence will still receive up to one bulk items collection per month at no additional cost. Collection limits remain the same. Residents must call at least 48-hours in advance of their desired pickup and options will be made available by Johns. This new program will help improve efficiency and decrease wear on Village roads by routing collection trucks directly to each home in need.



USEFUL INFORMATION

Please visit our website villageofbristol.org to make the following types of payments (except Burn Permits):

BURN PERMITS (payments not available online)

Outdoor fires require a burn permit which is valid January-December. Please call the Fire Department Burn Line at 857-4063 for the current burn status just prior to burning. Permits can be purchased at the Village Hall during regular business hours or at the Fire Department nights and weekends. First time permits are \$25, and renewals are \$15.

BUILDING PERMITS

If you are doing any type of home renovations please visit our website and complete a <u>building</u> <u>permit application</u>. A <u>zoning permit</u> is also required in addition to the building permit if you are building a garage, shed, fence, accessory building, or adding on to a building.

CREDIT CARD PAYMENTS at the Village Office

The Village of Bristol is now accepting credit card payments <u>in the village office</u> for anything payable to the village. There is a convenience fee of 3%.

ONLINE PAYMENTS NOW AVAILABLE!

Payments can now be made online for: sewer/water bills, taxes, invoices payable to the village, traffic citations, and building permits. There is a 2.75% convenience fee if paying with a debit or credit card, or a \$1 fee if paying by e-check. Visit our website to make your payments.
