If public works needs to come sweep in front of your house, you will be assessed a minimum fine of \$50.00

NOTICE: All vehicles must be properly licensed!!

Per Village Ordinance 10-5-8 Junked Vehicles and Appliances on Private Property, No disassembled, inoperable, **unlicensed**, junked or wrecked motor vehicles, truck bodies, tractors, trailers, farm machinery, vehicle parts or tires, or appliances shall be stored upon private residential property or unenclosed within a building upon nonresidential property within the Village of Cobb for a period exceeding ten (10) days.

There is an increased number of unlicensed vehicles parked on properties in the village. Please have these vehicles properly licensed, or have them removed. *If no action is taken, lowa County Sheriff's Department will be issuing citations.*

Please remember:





- Cobb has a 2 dog ordinance, this will be enforced by the lowa County Sheriff's Department
- Per Wisconsin Law, all dogs must be licensed each calendar year.
 Failure to do so will result in a fine.
- Please keep your dog(s) on your property. Dogs that are not trained to stay on your property must be on a leash or inside a fence.
- When walking your dog, please be courteous of other village residents and pick up after your dog!

Did You Know?

A glass container can go from a recycling bin to a store shelf in as few as 30 days.



Cross Connection Information Provided by Wisconsin Rural Water Assoc.

What is a Cross Connection?

A cross-connection is an actual or potential connection between the safe drinking water (potable) supply and a source of contamination or pollution. State plumbing codes require approved backflow prevention methods to be installed at every point of potable water connection and use. Cross-Connections must be property protected or eliminated.

How does contamination occur?

When you turn on your faucet, you expect the water to be as safe as when it left the treatment plant. However, certain hydraulic conditions left unprotected within your plumbing system may allow hazardous substances to contaminate your own drinking water or even the public water supply.

Water normally slows in one direction. However, under certain conditions, water can actually flow backwards; this is known as Backflow. There are two situations that can cause water to flow backward: backsiphonage and backpressure.

Backsiphonage

May occur due to a loss of pressure in the municipal water system during a fire fighting emergency, a water main break or system repair. This creates a siphon in your plumbing system which can draw water out of a sink or bucket and back into your water or the public water system.

Backpressure

May be created when a source of pressure (such as a boiler) creates a pressure greater than the pressure supplied from the public water system. This may cause contaminated water to be pushed into your plumbing system through an unprotected cross-connection.

Do...

- -Keep the ends of hoses clear of all possible contaminants.
- -Make sure dishwashers are installed with a proper "air gap" device.
- -Verify and install a simple hose bibb vacuum breaker on all threaded faucets around your home.
- -Make sure water treatment devices such as water softeners have the proper "air gap", which is a minimum of one inch above any drain.

Don't...

-Submerge hoses in buckets, pools, tubs, sinks or ponds.
-Use pray attachments without a backflow prevention device.
-Connect waste pipes from water softeners or other treatment systems directly to the sewer or submerged drain pipe. Always be sure there is a one inch "air gap" separation.

In the Bathroom – Toilet Tanks

There are many unapproved toilet tank fill valve products sold at common retailers which do not meet the state plumbing code requirements for backflow prevention.

-Look for the ASSE #1002 Standard symbol on the device and packaging -Replace any unapproved devices with an ASSE #1002 approved anti siphon ball-cock assembly. Average cost is typically \$12 to \$22 at home improvement stores.

In the Bathroom - Hand Held Shower Fixture

The hand held shower fixture is compliant if:

- When the shower head is hanging freely, it is at least 1" above top of the flood level rim of the tub.
- Complies with ASSE #1014
