Public Works will do their best to collect the trees once they appear on the curb. However, if a snowstorm is predicted, it is best to wait until the snow is cleared before you place

your tree out for pickup.

# Village of Dane Change in Municipal Court

Our municipal court will change from the Eastern Columbia County Joint Municipal Court to the North East Community Court on May 1, 2019. There are several steps in the process to make this change and the Village

### Winter Parking Rules Have Changed



A new ordinance was adopted in December, and became effective immediately; you may park on village streets during the winter unless the National Weather Service predicts a snow event of 1 inch or more. Once that

prediction occurs, then it is unlawful to park on any public street or alley between the hours of 2:00 am and 6:00 am. The restriction shall remain in place for 48 hours following the conclusion of the snow event.

# **2019 Elections**

Spring Election will be held on April 2, 2019. Two Village Trustee seats are up for election each year. This year, Don Lord and Zach Koenig's terms will expire in April. Caucus



will be held on Monday, January 7, 2019, at 7:00 pm prior to the regular Village Board meeting. To be placed on the ballot in April, you must attend Caucus, be nominated, and have that nomination seconded by a village resident. As of this date, there will be no statewide primary election in February.

### **Dog Tag Time Once Again**



Annual Dog License Renewal begins each year in January! All dogs residing in the Village **MUST BE** licensed. In order for the license to be issued the Rabies Vaccine Certificate must be presented annually. Spayed or neutered

dog tags cost \$10.00, and male or female dog tags cost \$15.00. Tags are provided by the county and of the fee collected \$8.75 and \$13.75 is turned over to the county. Late fees of an additional \$20 apply after March 31.
