  - b. Water Disconnections and Billing Issues
    Discussion was held on the need to disconnect the water of delinquent customers and set a
    precedence for the habitual delinquent customers. Each quarter there are approximately 60
    accounts that are delinquent with 10 having the balance from September moved to the Tax Bills.
