WHEREAS, the following Local Law was introduced as Proposed Local Law No. 3 of 2021, by Resolution No. 2021-011, adopted at a regular meeting of the Village Board held on July 14, 2021; and

WHEREAS, a properly noticed public hearing was held before the Village Board during the meeting on August 11, 2021, on Local Law No. 3 of 2021; and

WHEREAS, the enactment of this Local Law is a Type II Action pursuant to the New York State Environmental Quality Review Act as it involves routine agency administration and management and therefore is exempt from environmental review; and

NOW THEREFORE, BE IT ENACTED by the Board of Trustees of the Village of Millbrook as follows:

<u>Section 1</u>. Legislative intent: The Village Board of Trustees has determined it will be in the best interests of the Village and its residents for the fees charged for conducting an amusement

described in §63-1 of the Village Code shall be determined by the Village Board on an annual basis in the "Schedule of Fees" reviewed and updated at the annual re-organizational meeting of the Village Board.

<u>Section 2</u>. The existing §63-3 of Chapter 63 "Amusements" of the Village Code of the Village of Millbrook is hereby repealed in its entirety and replaced with the following language.

"§63-3 **Fees**

The fee for conducting any amusement described in §63-1 shall be established by the Village Board of Trustees on an annual basis in its "Schedule of Fees" which are reviewed and updated at the annual re-organizational meeting of the Village Board."

Section 3. All other provision of Chapter 63 "Amusements" shall remain unchanged.

<u>Section 4</u>. This local law shall take effect as of the date of filing with the New York Secretary of State.
