RESOLUTION No. 006 of 2020

<u>Introducing Local Law Amending Chapter 24 of the Village Code Which Addresses the Village Investment Policy</u>

At a meeting of the Village Board of Trustees of the Village of Millbrook ("Village Board"), held at the Village of Millbrook Village Hall on the 25th day of August, 2020, at 6:30 p.m., Village Deputy Mayor, Tim Collopy, called the meeting to order, and Trustee Rochfort, seconded by Trustee Herzog, moved the following resolution, to introduce the following proposed local law, to be known as Proposed Local Law No. 2 of 2020, entitled "A Local Law Amending Chapter 24 of the Village of Millbrook Village Code Regarding Investment Policy."

BE IT ENACTED by the Board of Trustees of the Village of Millbrook as follows:

<u>Section 1</u>. Legislative intent:

Chapter 24 of the Village of Millbrook Village Code contains the Investment Policy of the Village. The Village Board now wishes to amend Chapter 24 of the Village Code regarding Investment Policy to provide that the investment of all Village funds shall be as that approved by the Village Board in accordance with Section 11 of the New York General Municipal Law regarding "Temporary Investments."

- Section 2. The existing Chapter 24 of the Village Code of the Village of Millbrook, Sections 24-1 through 24-6 inclusive, is hereby repealed and substituted in its entirety with a new single Section, to be designated Section 24-1, which shall contain the following language.
- "§24-1 All investments of Village funds shall be approved by the Board of Trustees and shall be in compliance with New York State General Municipal Law §11 'Temporary Investments."
- <u>Section 3</u>. This local law shall take effect as of the date of filing with the New York Secretary of State.

Trustee Rochfort advised the Board of Trustees that, pursuant to the Municipal Home Rule Law of the State of New York, it will be necessary to hold a public hearing upon this proposed local law. Trustee Rochfort offered the following resolution which was seconded by Trustee Herzog, who moved its adoption:
