RESOLUTION No. 009 of 2020

<u>Introducing Local Law Amending Chapter 37 of the Village Code Which Addresses the Village Procurement Policy</u>

At a meeting of the Village Board of Trustees of the Village of Millbrook ("Village Board"), held at the Village of Millbrook Village Hall on the 25th day of August, 2020, at 6:30 p.m., Village Deputy Mayor, Tim Collopy, called the meeting to order, and Trustee Herzog, seconded by Deputy Mayor Collopy moved the following resolution, to introduce the following proposed local law, to be known as Proposed Local Law No. 5 of 2020, entitled "A Local Law Amending Chapter 37 of the Village of Millbrook Village Code Regarding Procurement Policy."

BE IT ENACTED by the Board of Trustees of the Village of Millbrook as follows:

<u>Section 1</u>. Legislative intent:

The Procurement Policy of the Village of Millbrook is set forth in Chapter 37 of the Village Code. The Village Board now wishes to amend Chapter 37 of the Village Code to simply provide that the Village Board shall review and update its Procurement Policy on an annual basis at it reorganization meeting and shall post such policy on the Village website.

- Section 2. The existing Chapter 37 of the Village Code of the Village of Millbrook, Sections 37-1 through 37-9 inclusive, is hereby repealed and substituted in its entirety with a new single Section, to be designated Section 37-1, which shall contain the following language.
- "§37-1 The Village of Millbrook has a Procurement Policy which is documented in the Policy-Section of the Village website and such Policy shall be reviewed and updated by the Village Board each year at its re-organization meeting.
- <u>Section 3</u>. This local law shall take effect as of the date of filing with the New York Secretary of State.

Trustee Herzog advised the Board of Trustees that, pursuant to the Municipal Home Rule Law of the State of New York, it will be necessary to hold a public hearing upon this proposed local law. Trustee Herzog offered the following resolution which was seconded by Deputy Mayor Collopy who moved its adoption:
