RESOLUTION No. 015 of 2020

Enacting Local Law Amending Sections 212-2 Through 212-6 of Chapter 212 of the Village Code Regarding the Shade Tree Commission

At a meeting of the Village Board of Trustees of the Village of Millbrook ("Village Board"), held at the Village of Millbrook Village Hall on the 8th day of September, 2020, at 6:30 p.m., Village Mayor, Michael Herzog, called the meeting to order, and Mayor Herzog, seconded by Deputy Mayor Collopy moved the following resolution, to enact the following local law, to be known as Local Law No. 6 of 2020, entitled "A Local Law Replacing Sections 212-2 through 212-6 of Chapter 212 of the Village of Millbrook Village Code with a single Section 212-2 providing that the governing rules of the Shade Tree Commission shall be contained in Bylaws within the Policies of the Village."

WHEREAS, the following Local Law was introduced as Proposed Local Law No. 6 of 2020, by Resolution No. 010 of 2020, adopted at a regular meeting of the Village Board held on August 25, 2020; and

WHEREAS, a properly noticed public hearing was held before the Village Board during the meeting on September 8, 2020, on Local Law No. 6 of 2020; and

WHEREAS, the Village Board determined the enactment of this Local Law will have no adverse environmental impacts and issued a Negative Declaration pursuant to the New York State Environmental Quality Review Act; and

NOW THEREFORE, BE IT ENACTED by the Board of Trustees of the Village of Millbrook as follows:

<u>Section 1</u>. Legislative intent:

Chapter 212 of the Village of Millbrook Village Code establishes a Shade Tree Commission and provides the authority under which the Shade Tree Commission operates. That authority includes the terms of office, compensation, duties and responsibilities and rules and

regulations of the members of the Shade Tree Commission. The Village Board intends to amend Chapter 212 of the Village Code to provide that the composition of and the rules governing the Shade Tree Commission shall be maintained in the policies of the Village of Millbrook under Shade Tree Commission Bylaws.

<u>Section 2</u>. Sections 212-2 through 212-6 inclusive of the existing Chapter 212 of the Village Code of the Village of Millbrook, are hereby repealed and substituted in their entirety with a new Section 212-2 which shall contain the following language.

"§212-2 There is hereby created and established a Shade Tree Commission for the Village of Millbrook, New York. The composition of that Commission and the Bylaws which govern it shall be found in the Policies of the Village of Millbrook under Shade Tree Commission Bylaws."

<u>Section 3.</u> The existing Sections 212-7 through 212-13 of Chapter 212 of the Village Code shall be renumbered accordingly following the substitution of the new Section 212-2 for the existing Sections 212-2 through 212-6.

<u>Section 4</u>. This local law shall take effect as of the date of filing with the New York Secretary of State.
