Village of Millbrook Board of Trustees Meeting Minutes

October 24, 2017

I. Call to order

Mayor Brown called the meeting to order at 6:30 PM and led the Pledge of allegiance.

Roll Call: Mayor Brown, Deputy Mayor Rochfort, Trustee Herzog, Trustee Van De Water, Trustee Hicks and Clerk Witt.

II. Administrative Business:

Clerk Witt read from the attached budget adjustments. Trustee Hicks made a motion to accept the budget adjustment as presented seconded by Trustee Van De Water and all were in favor.

Old Business:

Audio and Attachments: Mayor Brown told the Board that he received confirmation from Attorney Valk that it is ok to put on the website audio and attachments to meetings prior to the minutes being added to the website. Mayor Brown said audio and attachments to meetings will be put on the website within a day or two after a meeting.

Daniele Water Hook-up Questions: Mr. Daniele talked with Mr. Napoli of the Board of Health. Mr. Daniele is planning a walkthrough of their facility and is inviting Mr. Napoli and Mr. Bright (Delaware Engineering) to come. Mayor Brown stated he would also like to be included in the walkthrough. Mr. Daniele said he would contact Mayor Brown with a date.

Power Vent at Village Hall: Mayor Brown told the Board Pentek LLC submitted a proposal for a power vent at the Village Hall in the amount of \$3680. Trustee Hicks made a motion to accept the bid as presented, seconded by Trustee Herzog and all were in favor.

New Business:

Charlie Frisina resignation: Mr. Frisina submitted his resignation from the Planning Board to the Mayor (attached). Mayor Brown said if there is anyone interested in being on the Planning Board that they should submit a letter of intent (listing general information along with any qualifications). Mayor Brown stated the Rescue Squad is also in need of volunteers, specifically ambulance drivers, and anyone interested in volunteering should reach out to Laurie Olson at the firehouse. Deputy Mayor made a motion to accept Charlie Frisina's resignation, seconded by Trustee Van De Water and all were in favor. Optimum Rates: Mayor Brown received notice that Optimum will be raising their rates. Mayor Brown said the rates will be posted on the Village website.

Adwar: Mayor Brown informed the Board that Adwar came in at the state bid of \$25,669.38 for the equipment for the Public Access Channel.
