WHEREAS, Section 6-626 of the New York State Village Law provides that "all lands within the village which have been used by the public as a street for ten years or more continuously, shall be a street with the same force and effect as if it had been duly laid out and recorded as such"; and

WHEREAS, the following streets, or portions of streets, located in the Village of Millbrook have not been laid out and recorded as public streets but nevertheless Village records indicate such streets have been continuously used by the public, and maintained by the Village, since at least 2005.

NOW THEREFORE, BE IT RESOLVED, the Board of Trustees of the Village of Millbrook ("Village Board") hereby recognizes the following streets, or portions of streets, within the Village as having been used by the public as a street, and maintained by the Village as a Village street, for a
