WHEREAS, the Village of Oxford Board of Trustees shall discuss such decision(s) as a Village Board on an as needed basis so long as this resolution is in effect.

NOW, THEREFORE, BE IT RESOLVED, that the Village of Oxford Board does hereby acknowledge, accept and support the Village President to strategically implement necessary plans to ensure the safety and health of the Village of Oxford staff, residents and those traveling throughout the community with input from appropriate personnel and Marquette County resources; and
