

VILLAGE OF RIPLEY, OHIO

ORDINANCE NO. 1107

AN ORDINANCE REGULATING NEW OR UPGRADED SERVICE OF ELECTRIC POWER IN THE VILLAGE OF RIPLEY ELECTRICAL SERVICE AREA.

BE IT ORDAINED by the Council of the Village of Ripley, Brown County, Ohio, a majority or more of all members thereof concurring as follows:

SECTION 1. Standard Residential Electrical Service:

- (A) Standard residential electrical service not exceeding two hundred amps will be installed to customers of the Village of Ripley Electric Department at no charge provided the residence exists along an existing electric line and no additional poles are required.
- (B) Standard residential electric service requiring not more than one additional pole to reach the residence along existing Village roads, right of ways and easements will be installed to customers of the Village of Ripley Electric Department at no charge, provided however, that poles placed on private property such as a service drop for a trailer or R.V. Park shall be the responsibility of the owner.
- (C) Standard residential electrical service for new developments not previously served by the Village of Ripley Electric Department will be installed by the Village of Ripley Electric Department with one transformer providing two hundred amp service for two residential building lots at a cost of \$100.00 per residential building lot. In the event that the configuration of the development is such that only one lot can be served by a transformer, the cost to such lot will be \$200.00

SECTION 2. Overhead Transformer with Underground Residential Service.

- (A) In the event a customer of the Village of Ripley Electric Department desires underground service from an overhead transformer, the installation costs and service size shall be the same as set forth in Section 1 of this Ordinance, provided however, that the owner or developer of the lot shall be required to provide the homeowner, the Village of Ripley Electric Department and other non-Village utilities with the accurate location of any buried secondary electrical service.
- (B) The Village of Ripley Electric Department may require testing and examination of the buried service prior to making any connections to the secondary side of the transformer.

SECTION 3. Underground Residential Electric Service.

- (A) In the event a new development not previously served by the Village of Ripley Electric Department desires underground electric service, a sufficient number of transformers will be supplied to reach each residential lot. One transformer will normally supply two such residential lots and, in such case, each such lot shall be charged a \$400.00 installation fee for underground electrical service. In the event that the configuration of the development is such that only one lot can be served by a transformer, the cost to such lot will be \$800.00
- (B) In the event of underground electric service, the owner or developer of the lot shall be required to provide the homeowner, the Village of Ripley Electric Department and other non-Village utilities with an accurate location of any buried secondary electrical service.
- (C) In the event of underground electric service, the Village of Ripley will be responsible for informing concerned parties with the location of the primary side of the electric service buried in the development area.

SECTION 4. Material to be furnished by Village of Ripley.

The Village of Ripley Electric Department will furnish all transformers and the primary side of all electric service to customers within its service area.

SECTION 5. Payment schedules, Service Locations, and Service Preferences.

Payment schedules, service locations and service preferences will be agreed upon by the Village Administrator, the developer (or his agent) and the superintendent of the Village of Ripley Electric Department prior to installation of electrical service.

SECTION 6. This ordinance shall be in full force and effect from the earliest date allowed by law.
