The first day to circulate nomination papers is April 15, 2026, and the final day for filing nomination papers is 5:00 p.m. on Monday, June 1, 2026. Congressional and legislative district boundaries are described in Chapters 3 and 4 of the Wisconsin Statutes by 2023 Wisconsin Act 94, which is available at:
