AMMENDMENT TO 24.305 SANITARY AND STORM SEWER CONNECTIONS

D. Inspection of Connection

- 1. Notification to authority required. The applicant for the building permit shall notify the municipal approving authority when the building sewer is ready for inspection and connection to the municipal sewer. The connection shall be made under the supervision of the municipal approving authority.
- 2. System reconstruction. Inspection and connection procedures are as follows:
 - a) Inspection required. The village shall inspect all private connection to the Village of Stockbridge municipal sanitary sewer system at the time of that the private connection construction.
 - 1. Any existing private sewer lateral not meeting the requirement of the section or the Villages on private I/I shall be considered illegal.
 - 2. In the event that the private sewer system is found not to meet the requirements of this section, the Village shall notify the owner of the determined deficiencies.
 - b) Owner to correct deficiencies. The owner shall, at the owner's expense make the an necessary repairs to correct the deficiencies. The owner may elect to:
 - 1. Contract with licensed contractor to complete the repair. In doing so, the owner recognizes that all work must be done in strict conformance with all applicable local and state codes and in such a manner to correct the noted deficiencies. All work needed to be done at the expense of the owner.
 - 3. Have Village contractors, if available, complete the repair. The Village agrees that as part of a project, unit bid prices will requested for the calculation of the cost of making appropriate repair to the private building sewer.
- 3. System requirements.
 - a) All sanitary sewer mains and lateral, both public and private, shall be constructed and maintained in such a fashion that no clear water is allowed to enter into the sanitary sewer system.
 - b) The size, slope alignment, material or construction of a sewer, and the methods to be used in excavation, placing pipe, jointing, testing and backfilling the trench shall conform to the requirements of the building and plumbing code or other applicable rules and regulations. In absence of code provisions or in amplification thereof, the materials and procedures set forth in appropriate specifications of the ASTM, and W.P.C.F. (WEF) Manual of Practice No. 9 shall apply or Standard Specifications of Sewer and Water Construction in Wisconsin, latest edition.
 - c) The connection of the building sewer into the municipal sanitary sewer shall conform to the requirements of the building and plumbing code or the procedures set forth in appropriate specifications of the ASTM and W.P.C.F. (WEF) Manual of Practice No. 9. All connections shall be made gastight and watertight. Any deviation from the prescribed procedures and material must be approved by the municipal approving authority before installation.
 - d) Backflow water valves shall be required on all building sewers new or reconstructed at the location approved by the municipal approving authority.

E. Prohibited Discharges into the Sanitary Sewers

- 1. No person shall allow the discharge or cause to be discharged any unpolluted waters such as stormwater, groundwater, roof runoff, subsurface drainage, or cooling water to any sanitary sewer.
- 2. No person shall discharge waste or wastewater into the Village of Stockbridge sanitary sewer system with the exception of any provisions set forth by the Village of Stockbridge Sewer Utility Commission.

F. Right to Inspection

1. The Village of Stockbridge Utilities shall have the right to inspect any connection to the village sanitary sewer system. The Village may exercise this right by giving notice to the owner and the inspection shall be permitted to take place within 48 hours of the notice given to the owner of the property.

G. Penalties

1. Any person violating any provisions of this ordinance shall upon conviction be punished by forfeiture of not less than One Hundred Dollars (\$100.00) not more than Five Hundred Dollars (\$500.00) and the cost of prosecution. Each month of violation is a separate offense. If any person fails to comply with this ordinance after written notice of violation then the municipality may impose a penalty and rectify deficiencies. The expense to rectify deficiencies will be assessed as a special tax against the property.

This ordinance shall take effect upon passage and publication in accordance of law.
