A RESOLUTION MODIFYING THE WEST BOUNTIFUL CITY CONSOLIDATED FEE SCHEDULE FOR BUSINESS LICENSE FEES

WHEREAS, the West Bountiful City Council has previously adopted a consolidated fee schedule that lists fees for its direct and miscellaneous services to offset regulatory and administrative costs; and

WHEREAS, it is important to review and update its fees periodically; and

WHEREAS, it is necessary to update fees charged for business licenses to match changes in city ordinances and state legislation.

NOW THEREFORE, BE IT RESOLVED by the City Council of West Bountiful City that the West Bountiful Consolidated Fee Schedule be modified as reflected in the attached Exhibit A.

EFFECTIVE DATE. This resolution shall take effect immediately upon passing.

BUSINESS LICENSING

Commercial Business License Fee - General \$ 50.00/yr.
 Plus, for each full time employee \$ 5.00/yr.
 Plus, for each part time employee \$ 2.50/yr.
 Penalty for late filing if received after January 5 50% of ~~amount due~~ **license fee**
License fees will be discounted 50% on/after September-October 1 of each year
Clarify application of penalty, reduce discount period

Business Name Change \$ 25.00
Half of regular business license fee – does not require all verifications or inspections

Home Occupation License Fee ~~\$-no charge~~ ~~20.00/yr.~~
Application/Processing fee at time of initial filing \$ 15.00
Includes staff time to verify business information, sales tax information, schedule and track inspections if necessary

Solicitors, Canvassers, Peddlers License Fee \$ 25.00
 Plus, for each solicitor \$ 5.00/wk or
 \$ 20.00/mo
 Plus, all related admin fees (Bureau of Criminal Investigation, etc.)
 License is limited to 120 days and becomes effective ten days from issuance

Temporary Business License \$ 25.00
 Plus, per day **(maximum 120 days)** \$ 1.00 up to \$100
 Plus, Administrative fee if engaged in business prior to obtaining license \$ 50.00

Beer License
Application/Processing fee (per WBMC 5.12.030) \$ 25.00
Includes staff time to verify business and owner information, check backgrounds, process local consent request (Cathy, Mindi, Duane, Chief Erikson)

Class A (~~in original container for~~ off-premise consumption) \$250.00
 Class B (~~in original container for on or off~~-premise consumption) \$300.00*
 Class C (~~on draft for on-premise consumption~~ **Special Event/Temporary Beer Event**) \$TBD
 Class D (~~on draft for on or off-premise consumption~~) \$500.00
