Minutes of the Youth City Council Meeting of West Bountiful City held on Thursday August 23rd, 2018, at West Bountiful City Hall, Davis County, Utah.

1. Welcome/Attendance - Mayor Madeline Stokes called the meeting to order at 5:03 pm and welcomed everyone to the meeting.
2. Pledge of Allegiance - Madeline Stokes led the pledge of Allegiance
3. Youth Thought - Brandon Wood offered a thought.
4. Old Business:
 - a. Consider Approval of Minutes - We reviewed the minutes from August 9th, 2018; **Hayden Paxton made a motion to approve the minutes as presented and Nicole Wood seconded the motion. The vote was unanimous in favor of the Motion, with a vote of 15/15.**
 - b. WB-YCC T-shirts: We haven't ordered the t-shirts yet.
5. New Business:
 - a. Discuss YCC Bylaws: We read through them, but we haven't discussed them yet.
 - b. Consider Resolution on Mentoring: We discussed questions and comments on how and why the mentoring would work. We had the idea to have a meeting

before applicants apply for Youth City Council next year in March, as an introduction meeting to introduce all the positions. This is important, so they have the knowledge of what they are applying for before they apply.

We have connections to Bountiful High School, and Centerpointe Theater for costumes, we have a fog machine, and we have the idea to sell candy and drinks. We made the decision to make a Halloween Committee, who will oversee decorations and planning for this event. The members of the committee are: Nicole Wood, Tyson Williams, Sarahi Echeverria, Hayden Paxton, Maddi Stokes, Megan Charchenko, and Addison Feinauer. **Nicole Wood made a motion to approve the Halloween Committee and Addison Feinauer seconded the motion with a vote of 15/15.**
- d. Training - Retreat: The previous decision of going to Heber and riding the Murder Mystery Train, isn't available in the fall, so we discussed other ideas for our fall training retreat. We suggested the idea of going to see a play at Pickleville Playhouse in Bear Lake, or Locked in Escape Room in Logan, (which closes at 10:00 on Fridays), Nicole Wood was assigned to research these activities. We also found that there is a La Quinta (hotel) in Logan that we could stay in.

We again discussed the dates for the retreat:
