Members Excused: Megan Charchenko, Trista Eggett, Addison Feinauer, Bailey Hanson, and Christina Williams.

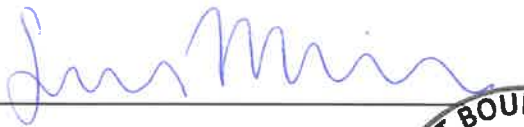
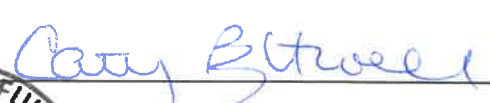
