Business:

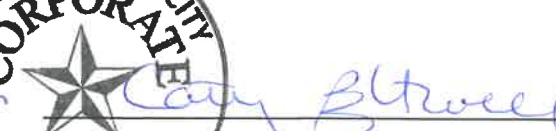
