WOODLAND CITY COUNCIL MEETING MINUTES
7:00 P.M. MONDAY JANUARY 13TH, 2025

CALL MEETING TO ORDER: Mayor Vince Suerth called the meeting to order at approximately 7:00 p.m.

PRESENT: Councilmembers Tom Newberry, Dave Daniels, Juan Vazquez and Hank Zucker

STAFF: City Administrator / Special Counsel Dan Madsen, Planning & Zoning Pat Smith and City Clerk Kimberly Lenarz-Greenwaldt

RESIDENTS: Jim Dowds

PLEDGE OF ALLEGAINCE:

The Council recited the Pledge of Allegiance

APPROVE CONSENT AGENDA:

Motion was made by Newberry, and seconded by Vazquez, to approve the Consent Agenda consisting of the following items:

- A. Approve December, 2024 City Council Meeting Minutes
- B. Approve Payment of Claims
- C. Approve 2025 Wayzata Fire Protection Agreement

Motion carried, Voting in favor: Suerth, Newberry, Daniels, Vaquez and Zucker.

MOTION FOR THE FLOOR:

Jim Dowds addressed the council about the Deer Management Plan that was discussed at the December meeting. Stating that the 10 deer that the council decided to remove was to much. After listening to Dowds the council decided to revisit the topic and put Deer Management Plan as B under Unfinished Business to discuss that the topic again.

PLANNING AND ZONING:

DRIVEWAYS

Woodland does not limit the number or width of driveways, this topic has been tabled from the December meeting. Smith explained to the council that himself & Martini had looked at Minnetonka's driveway ordinance and made some adjustments to Minnetonka's ordinance to meet requirements for Woodland. The recommended regulations require city engineering approval for all new driveway entrances and limit the number of driveway entrances.

Motion was made by Vazquez, to approve the proposed ordinance, seconded by Daniels.

Motion carried, Voting in favor: Suerth, Newberry, Daniels, Vaquez and Zucker.

UNFINISHED BUSINESS:

A. Discussion on Fire Service Biling Policy/ False Alarms

Madsen addressed the concern with the number of false alarms the Police & Fire Departments are dispatched to. The past two years have both had 19 False alarms calls that for the most part both Police & Fire have responded to. Even though some of these calls may have been called before either department reach the residence, it is still pulling staff from what they were doing and taking the time and resources to respond to a “false alarm”. After the discussion with the Council & staff it was decided that staff would present the council with fee recommendations for the false alarm calls at the February meeting.

B. Deer Management

At the December meeting council decided that Mike Kniss take up to 10 deer out of Woodland. Jim Dowds approach the council at the January meeting asking them to reconsider the amount of deer that they have given Kniss the approval to remove. After much discussion, the council decided that yes 10 deer was probably to many.

Motion made by Zucker that Mike Kniss cull up to 5 deer out of Woodland, Vazquez second the motion. Motion carried, Voting in favor, Suerth, Daniels, Vaquez, Newberry and Zucker.

NEW BUSINESS:

- A. Motion was made by Newberry, and seconded by Vaquez to approve Resoltuion 01-25 the 2025 Woodland Calendar. Motion Carried, Voting in favor, Suerth, Daniels, Vaquez, Newberry and Zucker.
- B. Motion was made by Zucker and seconded by Newberry to approve Reolution 02-25 the 2025 Administration Fee Schedule. Motion carried, Voting in favor, Suerth, Newberry, Zucker, Vaquez and Daniels.
- C. Vazquez asked if Fire could be added to his list of Assignments. Motion was made by Daniels and seconded by Newberry to add Fire to Vaquez list of Assignments and to approve Resolution 03-25 the 2025 Assignments and Appointments. Motion was carried, Voting in favor, Suerth, Zucker, Newberry, Vaquez and Daniels.
- D. Motion was made by Vaquez and seconded by Zucker to approve Resolution 04-25 the Establishing a Date for 2025 Local Board of Appeals. Motion was carried, Voting in favor, Suerth, Daniels, Zucker, Vaquez and Newberry.
- E. Staff had put a survey out on the Woodland City website asking residents if they would like to move the City Council start time. With only 19 responses so far, Mayor Suerth suggested that they extend the survey and see what next month brings for votes.
- F. Madsen presented the council with an Unaudited Financial report letting them know that numbers will move after/during the budget and with year money that more than likely be coming from the county.



Last year, long-time Woodland Property Assessor, Dan Distel, retired. Along that same timeline, Hennepin County approached the Council and offered to take over property assessment and valuation services at no cost to the City. Based upon the timing and equity of their offer, the Woodland Council appointed Hennepin County as our local assessor.

Michael Smerdon has been assigned by the Hennepin County Assessor's Office as our local property appraiser. Staff have asked Mr. Smerdon to appear at our next meeting to provide a preliminary update on the most recent property appraisal results and explain the anticipated impacts on Woodland property valuations from both the shift to Hennepin County as our assessor and based upon comparable sales and market valuation trends.

The 2025 Woodland market valuation data was set for approval by Hennepin County in the afternoon of February 5, so no information was available at the time this Memorandum was drafted. Mr. Smerdon will have a memorandum and the supporting data for our review at the Council Meeting, if not sooner. When received, Staff will send along that information to provide the Council with as much time as possible for review. Staff and the Council will have the opportunity to ask Mr. Smerdon questions to gain a better understanding of what our residents will see when they receive their property tax statements next month, and what factors and information led to any changes in property valuations.

Fire and Police Service Billing Policy

The Woodland City Council began a discussion regarding the billing of fire service calls dispatched to Woodland addresses at the December City Council Meeting. Woodland Ordinance Section 430 entitled “Fire Response” requires that the City of Woodland “collect from the owner of record of a property requiring a fire response a portion of whatever sum the City is obligated to pay... whether the fire call was real, a false alarm, or an unintentional call.” Woodland Ordinance §430, Subd. 02(a). The fee to be charged to properties for which fire calls were dispatched is \$250 for the first call, with a second and subsequent fire calls being \$500 if placed within the same calendar year as set by Ordinance §430, Subd. 02 and §305.02. These costs and expenses can be assessed to the subject properties annually upon nonpayment. Ordinance §430.03. Members of the Council and Staff again discussed this matter at our January Council Meeting and reviewed the challenges and inequities involved in the current Ordinance and process.

Members of the Council and Staff also discussed and reviewed the Police Response / Billing Ordinance contained in Chapter 445 entitled “False Alarms - Police.” As discussed at our January Council Meeting, the Police False Alarm policy only bills residents for false alarms, which seems to be in alignment with the equitable considerations discussed by the Council of not billing people seeking help for themselves or others. Pursuant to Woodland Ordinance §305.02, citing Ordinance 445.02, billing of Police false alarms begins upon the third occurrence and in the amount of \$100; with the fourth false alarm being \$200 and fifth and subsequent false alarms being billed at \$500 per instance within the same calendar year. Interestingly enough, Woodland Ordinance §445.02 is contradictory and states that the property owner will receive an alarm user fee upon the fourth false alarm in the amount of \$50. This user fee increases by \$50 to a total of \$100 after six false alarms and increases an additional \$50 for a total of \$150 after ten false alarms in the same calendar year.

Based upon discussions at our December and January Council Meetings, and after the review of this matter with Police Chief, Cory Johnson, Staff have prepared Ordinance Amendments as presented herein that will align the Police and Fire Call Ordinances and establish billing only for false alarm calls beginning after the first false alarm each calendar year. The second false alarm responded to will incur a \$100 fee, with the third and all subsequent false alarm calls in a calendar year incurring a \$500 fee. This fee would be separate for Police and Fire false alarm responses, meaning that the second false alarm would incur one fee for the Police response, and an additional fee for the Fire response if both units responded. Also as discussed, false alarm fees will only be charged for incidents to which the Police and / or Fire Departments actually respond. Calls that are cancelled will not be subject fees. There will not be any fee assessed for emergency calls for service. The appeal process would remain unchanged, where aggrieved residents can appeal their fines directly to the City Council.

Attached for your review are redlined Amendments to the Fire and Police Billing Ordinances, along with clean versions at the end of this Memorandum for publication. Staff can make any additional

changes or edits you would like to see. Otherwise, upon your approval, these Ordinance Amendments will become effective upon publication, which should occur by the end of the month. Staff have also included an Amendment of Section 305 “Fees” to update and reflect the proposed fee changes as provided herein. All three Ordinances are recommended to be approved with publication being done by summary publication as provided herein.

Ordinance XX-25 Amends Section 305.02 of the Woodland City Code to update Police and Fire False Alarm Fees for the second and all subsequent false alarms to a Woodland residence as defined in Sections 445.02 and 430.02 of the Woodland City Code. This replaces the method of billing for fire and police calls originating at a property or benefiting a property in Woodland and / or the fee structure for establishing and billing fees for false alarm calls.

WOODLAND CITY CODE, CHAPTER 430 FIRE RESPONSE

SECTION 430 - FIRE RESPONSE

430.01 Outside Fire Service. The officers and employees of a city, and any members of a volunteer fire department of a city, that the City of Woodland contracts with for fire service, are authorized to enter upon private property within the City of Woodland for the purpose of extinguishing any fire in response to a call.

430.02 General Definitions. For the purposes of this section, certain words and terms shall have the following meanings:

(a) Alarm User. This means the person, firm, partnership, association, corporation, a company or organization of any kind in control of any building, structure, or facility where an alarm system is maintained.

(b) Alarm System. This means and includes any alarm installation designed to be used for the prevention or detection of burglary, robbery, fire or a medical condition on a premises which contains the alarm installation. Auto alarm devices shall not be considered an alarm system under this section. An alarm which alerts an alarm user on the premises and requires the user to make a personal inspection of the premises and then a personal phone call to the Police or Fire Department (such as a smoke and CO detector or automobile alarm) is not considered an alarm system under this section.

(c) False Alarm. This means an alarm signal eliciting a response by Police or Fire personnel when a situation requiring a response does not, in fact, exist, and which is caused by the activation of the alarm system through mechanical failure, alarm malfunction, improper installation or the inadvertence or deliberate act of the owner or lessee of the alarm system or of his/her employees or agent. False alarms do not include alarms caused by climatic conditions such as tornadoes, thunderstorms, utility line mishaps, violent conditions of nature or any other conditions which are clearly beyond the control of the alarm manufacturer, installer or owner.

430.03 False Alarm Fees. If an alarm user has been notified of an alarm system which reports a false alarm to the City in a single calendar year, the alarm user will be charged a fee of one-hundred dollars (\$100.00) for a second false alarm in a calendar year; and a fee of five-hundred dollars (\$500.00) for the third and each subsequent false alarm in a calendar year.

430.04 Appeal of Fee. Any alarm user charged the user fee under Section as a result of false alarms may make a written appeal to the Chief of Police within 10 days of notice by the City of the false alarm fee. A decision by the Chief of Police may be appealed to the City Council, who will have authority to make a determination as to whether the appellant is to be charged with the false alarm.

430.05 Notice of False Alarm. Upon receipt of the first false alarm report at an address, the Police Department shall by mail attempt to notify the alarm user of the provisions of this ordinance. Upon receipt of the fourth and all subsequent false alarm reports at the address, the City Clerk shall notify the alarm user that an alarm user fee is due.

430.06 Payment of Fees. Payment of user fees must be made to the City Treasurer within 30 days of the date of notice by the City to the alarm user. Failure to pay the fee within 30 days notice will cause the alarm user to be charged an additional service fee equal to 10% of the user fee.

430.07 Collection with Taxes. All delinquent charges for user's fees shall be a lien upon the premises. All charges which are on September 30 of each year more than 45 days past due; shall be certified by the City Clerk to the County Auditor to be extended by the Auditor on the tax rolls against such premises in the same manner as other taxes, collected by the County and paid to the City.

430.08 Injunctive Relief. In the event of a violation or a threat of violation of this ordinance, the City may institute appropriate action or proceeding, including requesting injunctive relief to prevent, restrain, correct, or abate such violation or threatened violation. 445.08 Civil Action. In addition to all other legal remedies, if a person fails to comply with the provisions of this ordinance, the City may recover costs, damages, or alarm user fees in a civil action in any court of competent jurisdiction.

430.02 Fire Call Service Fee.

(a) The City of Woodland shall collect from the owner of record of the property requiring a fire response a portion of whatever sum the City is obligated to pay to the city providing fire protection, whether the fire call was real, a false alarm, or an unintentional call.

(b) Fees for all fire calls (real, false alarm, or unintentional) are set by the City Council and specified in Section 305.02 of the City's Code of Ordinances.

(c) Upon receipt of a fire call notice from the city, providing fire service to Woodland, the City Clerk shall notify the owner of record of the property requiring a fire response that a fire call service fee is due.

(d) All fees charged to the property owner are due and payable to the City Treasurer 30 days after either a notice in writing from the Clerk or 30 days following a determination by the City Council that a fee is due, if a later date. If the required payment is not made within 60 days of such notice or determination, an additional delinquency charge of \$100 will be added and will be payable by the owner.

(e) An owner of record charged a fire call service fee may make a written appeal to the Council within 10 days of receipt of notice from the City that a fire call service fee is due. The City Council, at its next meeting, shall make a determination as to whether the appellant is to be charged for the fire call.

430.03 Certification of Delinquent Payments. All unpaid charges shall be a lien upon the premises when due. All charges which on September 30 of each year are more than 60 days past due shall be certified by the City Clerk to the County Auditor to be extended by the Auditor on the tax rolls against the premises in the same manner as other taxes, and shall be collected by the County and paid to the City.

~~430.04 Allocation of Costs Among Properties. If the Council determines that a property in the vicinity of a fire has been protected or saved from damage by the fire department of a city that the City of Woodland has a contract with, the City Council may allocate a portion of the fire call service fee to the property in the vicinity of the fire on whatever basis the City Council deems just and equitable. The owner of property against which a portion of the fee has been allocated will be obligated to reimburse the City of Woodland Chapter 4 – Public Health and Safety 27 for whatever amount the City Council has allocated to the property, in the same manner as prescribed in Subsection 430.02.~~


